### Message from the Chairperson



Welcome to the 2014 edition of the Belfast Domestic Violence Partnership Newsletter.

I have recently been appointed to the post of Children's Services Manager in the Belfast Trust and will take up post in June including Chairing the Belfast Domestic Violence Partnership.

As you will note from the content of the Newsletter the Partnership has continued with a busy work programme including a number of events over the past 12 months.

In partnership with South Eastern Domestic Violence Partnership a conference was held in November attended by approximately 300 staff from a range of agencies . Thanks to the DHSSPS and PSNI which provided funding for the conference. Raising awareness with groups such as Dental Students and Midwives has been ongoing.

The New Year started with a focus on planning joint initiatives with the District Policing and Community Safety Partnerships (PCSPs) across the greater Belfast area to raise awareness regarding Domestic Violence / Abuse with events in February and March in the North, East and Castlereagh districts. Many thanks to the District PCSP's for their funding and support with these events.

During the past year the Protection and Justice Group established a project which aims to enable staff in the community, voluntary and statutory sectors to better support victims and their children involved in Contact/ Residence Order Applications. Guidance to assist frontline staff working with families experiencing domestic violence/abuse and child contact arrangements was developed and three seminars in June, September and October were organised to promote the guidance to a range of staff. More recently the Guidance has been presented to Lay Magistrates in Belfast and Banbridge.

At a regional level work on the new draft Joint Domestic and Sexual Violence Strategy was issued in January for consultation. The Partnership has continued to contribute to the process through attendance at the Regional Strategy Group and has responded to the consultation.

I would like to take this opportunity to thank everyone who has continued to contribute and support the work of the Partnership and I look forward to working with you all and continuing to progress the partnerships work plan.

#### **Public Consultation**

Stopping Domestic and Sexual Violence and Abuse in Northern Ireland 2013-2020 closed April 2014

The Departments of Health, Social Services and Public Safety and the Department of Justice launched the public consultation on the Stopping Domestic and Sexual Violence and Abuse in N.Ireland on the 15th January 2014.

The proposals aim to put in place enhanced services, protection and support for all victims and witnesses of Domestic and Sexual Violence and Abuse, and to ensure perpetrators are called to account. 56 responses have been received and the joint DHSSPS/DOJ team is currently analysing the responses in order to identify the key issues for consideration and these will be subject to wider discussion in the near future.

#### **BEHIND CLOSED DOORS ......**

A range of speakers considered the impact of Domestic Violence on children and young people, adults and older people and appropriate services and interventions to support victims. Keynote speaker Professor Nicky Stanley, Professor of Social Work at the University of Central Lancashire said "It is vital to emphasise the importance of front line staff listening to what children say about domestic violence and to argue for parallel group interventions that support children and their mothers who have experienced domestic violence"

James Knox, Coordinator Men's Advisory Project highlighted the barriers to male victims disclosing domestic abuse as;

- Knowledge of what constitutes abuse
- Recognizing that they are victims
- Stigma
- Fear of not being believed and losing contact with their children.

#### LISTENING, SHARING AND LEARNING ......

The Listening, Sharing, and Learning conference jointly organised by Belfast and South Eastern Domestic Violence Partnerships, and funded by the DHSSPS and the PSNI took place in the Clandeboye Lodge on the 29th Nov 2013. The conference was opened by the Minister of Justice Mr David Ford.

300 delegates heard speakers from Northern Ireland and England highlight the importance of sharing critical information across sectors and agencies, the importance of listening to victims and responding appropriately, and the lessons learnt from Domestic Homicide Reviews in England.

Following the opening address by Minister Ford, Frank Mullane shared his poignant story of the murder of his sister Julia and nephew William by Julia's husband. Frank now works to support families following fatal domestic abuse and has advised and contributed to Domestic Homicide Reviews across England. #### Belfast Domestic Violence Partnership publishes Child Contact Guidance

(August 2013)

In response to issues raised by victims and staff, members of the Belfast Domestic Violence Partnership Protection and Justice working group developed guidance which aims to assist frontline staff working with families experiencing domestic violence/abuse and child contact arrangements. In addition the guidance will support individuals who choose to represent themselves in court proceedings (self litigants).

Three seminars in June, September and October 2013 were organised to promote the guidance to a range of staff. More recently the guidance has been presented to Lay Magistrates in Belfast and Banbridge in conjunction with SET Domestic Violence Partnership.

## "What has Domestic Violence got to do with me anyway"?

This was the question posed at a study day coordinated by the Belfast Domestic Violence Partnership for dental students at the Centre for Dental Education at the Royal Victoria hospital site in November 2013 attended by approximately sixty second year dental students and their lecturers. Speakers from PSNI, Belfast and Lisburn Women's Aid and the Probation Service contributed to the programme alongside Catriona O Hare, Clinical Dental Teaching Fellow at QUB.

Speaking on the importance of dentists recognising domestic violence as A health issue, Catriona noted that "Dentists form long term relationships with their patients and families and so are in an ideal position to notice changes in someone's appearance or behaviour. It is a well-known fact that the teeth, face and head are the most commonly injured sites in incidents of domestic abuse and victims will often seek dental help for these problems. In a recent study 70% of patients who sought help from their dentist wished the dentist had asked about their injuries."

The awareness day explored the nature, extent and impact of domestic violence and abuse and the services available to support victims. The role of the dental practitioner and the simple steps dentists can take to help their patients was discussed.

#### Domestic Violence Study Day for Midwives

The event which was sponsored by Danone and coordinated by the Domestic Violence Partnership was held in the Ramada Hotel at Shaws Bridge on the 5th November 2013. Approximately 90 midwives attended and heard speakers outline the impact of domestic violence including the indicators of abuse and the power and control dynamics in abusive relationships. Information on appropriate services was discussed and the role of the midwife in responding to domestic violence and abuse was highlighted by Sister Margaret Kennedy RJMH who stressed the importance of midwives keeping Domestic Violence on

Belfast Domestic Violence Partnership MARAC working group

The Belfast Domestic Violence Partnership MARAC Subgroup continues to meet and has agreed the groups work plan.

The group has been considering local practice issues and training and development needs and communicates issues raised to the Regional MARAC Operational Group.

#### MARAC Operating Protocol

A final version was agreed at the Regional Strategic group and MARAC Operational group meetings in May 2014. The protocol will be implemented from the 1st June 2014.

MARAC Information Sharing Agreement (ISA)

The ISA has now been signed off by all signatories from the statutory agencies. The document will be reviewed in six months from the date that the final signatory was received and thereafter every two years.

#### MARAC Leaflets

Two sets of MARAC leaflets have been published one for victims and one for practitioners. It is recognised that the leaflets will need amended once IDVAs are in place and therefore a limited supply has been printed initially.

### News from Home ...

#### PSNI Stats 2013 -2014 published May 2014

Incidents & Crimes with a Domestic Abuse Motivation at highest levels since 2004-2005

- There were 7 murders with a Domestic Abuse Motivation
- There were 27,628 incidents with a domestic abuse motivation an increase of 438 (1.6%) on the 27,190 incidents recorded in 2012/13.
- There was a greater increase in the number of crimes having a domestic abuse motivation with 12,720 recorded in 2013/14 compared with 11,160 in 2012/13, an increase of 1,560 (14.0%).
- The associated crime outcome rate fell by 5.0 percentage points from 36.7% in 2012/13 to 31.7% in 2013/14.

#### Reaching out to older women - The Older Women's Project

**Belfast & Lisburn Women's Aid** has been awarded £200,000 for a project to support older women. The grant, awarded by the Big Lottery Fund, will be used to reach out to older women who suffer domestic violence in the area.

Previous research by Belfast and Lisburn Women's Aid has found that one in six women over 60 suffer from some form of domestic abuse.

Two dedicated staff have been appointed and referrals will be accepted from any agency

Professor Gene Feder, from the University of Bristol's School of Social and Community Medicine, said: "Domestic violence is a crime and breach of human rights with major public health and clinical impact.

Screening women in healthcare settings is national policy in some countries. By looking at research trials carried out around the world, we found no evidence that screening improves access to specialist domestic violence support or leads to a reduction of violence. This is an example of research that tells us what not to do. Yes, doctors and nurses need to ask women patients about abuse, but not all women patients. We need to shift the research focus towards developing effective care for survivors of domestic violence after they have disclosed, however they are identified."

## The World Health Organisation publishes new clinical and policy guidelines

## "Responding to intimate partner violence and sexual violence against women"

The guidelines are based on systematic reviews of the evidence, and cover:

- \* identification and clinical care for intimate partner violence
- clinical care for sexual assault
- \* training relating to intimate partner violence and sexual assault against women
- \* policy and programmatic approaches to delivering services
- \* mandatory reporting of intimate partner violence.

The guidelines aim to raise awareness of violence against women among health-care providers and policy-makers, so that they better understand the need for an appropriate health-sector response. They provide standards that can form the basis for national guidelines, and for integrating these issues into health-care provider education.

### Scotland and Wales ...

#### "CLAIRES LAW" TO BE PILOTED IN

"A scheme allowing people to find out whether their partner has a history of domestic violence, known as Clare's Law, will be piloted in Scotland.

First Minister Alex Salmond, who is also considering a new domestic abuse offence, outlined a planned trial of the police disclosure scheme.

It is named after Clare Wood, who was murdered by her ex-boyfriend George Appleton in Salford, Greater Manchester, in February 2009

A similar scheme was rolled out across England and Wales earlier this year.

Police recorded 60,080 incidents of domestic abuse in Scotland in 2012-13, up slightly from 59,847 in the previous year."

#### North Wales Police March 2014

"In the year 2012/13, out of over 13,745 domestic incidents which were reported to North Wales Police, 4,200 resulted in a domestic crime having occurred.

Out of this number, over 35.43% were referred to the Crown Prosecution Service for advice.

Last year our conviction rate at court for domestic abuse crimes was 77%.

This year to date we have improved our conviction rate to 81.1%"

#### On one day in Scotland 2013 .....

- 341 women and 257 children and young people were living in a Women's Aid refuge
- 809 women and 319 children and young people were supported by a Women's Aid group
- 82 women and 12 children and young people contacted Women's Aid for the very first time
- ♦ 37 women and 22 children and young people asked for refuge accommodation, but Women's Aid groups were unable to find suitable spaces for 19 women and 5 children and young people.

# "New guidelines are to be introduced for prosecutors handling cases of domestic abuse among the elderly and teenagers

The Crown Prosecution Service (CPS) advice for England and Wales says older people may face more frequent attacks because they are less independent.

It makes clear abuse may not always involve violence - warning that young people my face abuse via mobile phones and social media.

The advice will be consulted on before coming into force."

Clare's Law, which enables people to check the police record of their partners, is to be expanded to cover all of England and Wales.

Piloted in Greater Manchester, Wiltshire, Nottinghamshire and Gwent since September 2012 the scheme is expected to take effect across England and Wales in March 2014

Clare Wood's father, Michael Brown, has welcomed plans to roll out the scheme, officially known as the Domestic Violence Disclosure Scheme, saying the scheme "could, quite possibly, have saved her life".

Home Secretary Theresa May, issued a written statement to the House of Commons saying that there "are still too many cases where vulnerable people are let down".

"Clare's Law provides people with the information they need to escape an abusive situation before it ends in tragedy," she said.

Domestic violence protection notices and orders implemented across England and Wales from March 14

Domestic violence protection orders are a new power that fills a gap in providing protection to victims by enabling the police and magistrates to put in place protection in the immediate aftermath of a domestic violence incident.

A perpetrator can be banned with immediate effect from returning to a residence and from having contact with the victim for up to 28 days, allowing the victim time to consider their options and get the support they need.
